The Conference will have three sections:

THE THEMES OF CONFERENCE

The Conference is a platform of international legal debate that examines recent developments and prospects for development of business law. Within the framework of the Conference will be presented **scientific papers in all areas of legal sciences**, which will be scored according to their content in one of three sections.

The Conference opens its doors to authors from different countries, from the legal education space and from the practitioners of law, encouraging presentation both scientific papers of international interest covering comparative law, European Union law, international trade law, public international law, as and scientific papers to highlight the particularities of national law.

At the Conference may participate, both the people who want to submit a scientific paper, as well as the people who just want to hear the debate, without the submission of scientific papers.

The authors have the opportunity **to submit a second scientific paper** at the Conference paying an additional fee.

The Conference will focus on a wide range of **subjects** related to business law, among which we mention (**enumeration has illustrative and not restrictive role**):

Section I. Public Law

Indicative themes:

- **General Theory of Law** (the state's role in different types of economies, the rule of law - an instrument of state intervention in the economy, law systems and the regulation of economic markets etc.).
- **Constitutional Law** (constitutional regulations in business, economic actor's rights guaranteed by the Constitutions etc.).
- **Administrative Law** (administrative acts with impact on the business environment, administrative contracts, administrative establishments of economic market surveillance, administrative regulations affecting the business environment, the role of information technology in the relationship between government and business, the concept of e-government, the State role in business development, the State and protection of the consumer, elements of the urban planning law etc.).
- **Financial Law** (taxation systems, tax changes imposed by economic crisis, fiscal systems and the business environment etc.).
- **Customs Law** (customs procedures, customs duty etc.).
- **Criminal Law and Criminology** (economic crimes; research methods of economic crime, criminal liability of legal persons, criminological theories about crime in the business environment etc.).
- **Internet Law** (protection of individuals with regard to processing of personal data on the Internet, electronic signature, electronic commerce, Internet users' rights, legal documents in electronic form; online dispute resolution (ODR) in the European Union, cybercrime etc.).
- **Environmental Law** (liability for environmental damage caused by economic activities, environmental management systems etc.).
- **Comparative Public Law**

Section II. Private Law

Indicative themes:

- **Civil Law** (legal entity - the holder of rights and obligations, patrimony of legal entities, etc.).

- **Commercial Law** (establishment, organization, operation of commercial companies; authorized individuals; insolvency; types of regulated business; fund of commerce etc.).
- **Contract Law** (the contract - tool for achieving the business, types of contracts used in domestic and international commercial activity etc.).
- **Banking Law** (the role of central banks, regulation of credit institutions, banking transactions and contracts, payment instruments, input trends of banking law in public law framework etc.).
- **Insurance Law** (the role of the insurance in the business environment, EU regulations in insurance, commercial insurance companies, insurance contracts etc.).
- **Labor Law** (types of clauses in individual employment contracts, the legal framework for achieving the relations between employer and employee etc.).
- **Professional Law** (the liberal professions and the business environment etc.).
- **Transport Law** (contracts for commercial transport, intermodal transport of goods etc.).
- **Commercial Arbitration and Mediation** (arbitration clause, organization and functioning of courts of arbitration, case law, the mediation role in resolving disputes etc.).
- **Intellectual Property Law** (legal protection of patents, copyrights, trademarks and industrial secrets etc.).
- **Land and Real Estate Law** (regulatory role in real estate development, legal circulation of property etc.).
- **Capital Markets Law** (protection instruments of regulated markets and investors, stock exchange operations etc.).
- **Comparative Private Law.**

Section III. European Union Law. International Law

Indicative themes:

- **Legal Environment of Business in the EU** (Single Market legislation, transposing directives into national law etc.).
- **Public International Law** (influence of Treaties between States on the business environment, cross border cooperation etc.).
- **International Commercial Arbitration** (arbitration courts, case law etc.).
